### DIRECTIONS:

1. Test in an inconspicuous area for safe use on fiber or surface.
2. Remove excess contaminant before applying Avenge Pro™.
3. Apply spotter directly to the contaminated area. Agitate with a spotting spatula (bone scraper or Gum Getter™), working into a foam. Remove foam along with suspended contaminant into an absorbent towel.
4. Rinse with water and extract (preferred) or blot with a clean absorbent towel.
5. If any stain remains apply Bridgepoint All Solv

### DESCRIPTION:

Avenge Pro™ will work alone on a wide variety of difficult stains, including protein stains like egg, blood, grass stains, and tougher stains like ink, permanent marker, lipstick, shoe polish, grease, oil, tar and more. For especially difficult stains like paint, fingernail polish, or other resins, combine with Bridgepoint's All Solv Extreme gelled solvent stain remover.

Extreme, agitate, apply Avenge Pro,™ agitate and rinse thoroughly.

6. For upholstery or delicate fibers, apply Avenge Pro™ to a towel and blot the stain. Repeat if necessary and thoroughly rinse.

### CONTENTS:

Water (CAS #7732-18-5), Proprietary Surfactants/Polymer Blend, and Propanediol (CAS #504-63-2).

### INSTRUCCIONES:

1. Haga una prueba en un área poco visible de la fibra o superficie antes del uso.
2. Retire el exceso de suciedad antes de aplicar Avenge Pro.™
3. Aplicar directamente a la zona contaminada. Agitar con una espátula (como por ejemplo, Getter Gum™), hasta la que la consistencia sea espuma. Retire la espuma junto con los contaminantes con una toalla absorbente.
4. Enjuague con agua y extraiga (de preferencia) o seque con una toalla absorbente limpia.
5. Si la mancha persiste aplique Bridgepoint All Extreme Solv y restriegelo, luego aplique Avenge Pro™ restriegelo y luego enjuague bien.
6. Para las fibras de tapicería o delicadas, se aplica Avenge Pro™ a una toalla y seque la mancha. Repita si es necesario y enjuague bien.
