*Carpet:* Add 1 to 2 oz. per gallon to your favorite ready-to-use traffic lane cleaner.

*Upholstery:* Add 1 to 2 oz. per gallon to your favorite ready-to-use upholstery cleaner.

Do not saturate or wet carpet backing with Citrus Solv II as it may cause temporary swelling.
