### DIRECTIONS

2. Remove excess contaminant before applying Avenge Pro™.
3. Apply spotter directly to the contaminated area. Agitate with a spotting spatula (bone scraper or Gum Getter™), working into a foam. Remove foam along with suspended contaminant into an absorbent towel.
4. Rinse with water and extract (preferred) or blot with a clean absorbent towel.
5. If any stain remains apply Bridgepoint All Solv Extreme, agitate, apply Avenge Pro, agitate and rinse thoroughly.
6. For upholstery or delicate fibers, apply Avenge Pro to a towel and blot the stain. Repeat if necessary and thoroughly rinse.
