**DIRECTIONS:** To be used as the primary cleaning agent or as a rinse/cleaning aid, in the extraction process for carpets and upholstery.

For truck mount concentrate: Add 6 scoops (scoop = 2 oz) Fiber Plus to five gallons of cold or warm water. Mix thoroughly until dissolved. For systems metered on low settings or for excessively soiled carpets 3 cups may be used.

For special case, hard-to-remove and heavy soil, add 12 scoops (scoop = 2 oz.) to five gallons of water. For extra heavy soil use 2 ounces per five gallons of hot water.

For portable equipment: Use half a scoop (1 oz.) Fiber Plus per 5 gallons hot water. Mix thoroughly until dissolved. For special case, hard-to-remove and heavy soil, use 1 scoop per five gallons of hot water.

FIBER PLUS es un emulsionador de extracción de Última Generación, el cual ha sido aprobado para su uso en alfombras de quinta generación. Un limpiador de pH controlado que emulsiona y suspende eficazmente aun la suciedad más difícil de quitar, al mismo tiempo que limpia con suavidad la mayor parte de las tapicerías.

### INSTRUCCIONES:

Se debe utilizar como agente principal de limpieza o como ayuda de enjuague en los procesos de limpieza por extracción de alfombras y de tapicería.

Para los sistemas montados en camión: Añada 6 cucharadas (cucharada = 2 oz.) de Fiber Plus a 5 galones de agua fría o tibia (19 ml por litro—1:52). Mézclelo completamente hasta que se disuelva. Para los sistemas con un medidor que ha sido fijado a un valor bajo, o para las alfombras extremadamente sucias, se pueden usar de 3 (37 ml por litro—proporciones de 1:27, respectivamente).

Para casos especiales, difícil-de-quitar y suciedad pesada, añadir 12 cucharadas (cucharada = 2 oz.) a 5 galones de agua. Para suelos muy sucios utilice de 2 onza por 5 galones de agua caliente (de 3.0 ml por litro—1:320).

Para equipos portátiles: Utilice de medio cucharada de Fiber Plus por 5 galones de agua caliente (de 1.5 ml por litro—1:640). Mézclelo completamente hasta que se disuelva. Para casos especiales, difícil-de-quitar y suciedad pesada, utilice 1 cucharada a 5 galones de agua caliente.
