DIRECTIONS

1. Remove loose or excess residue.
2. Apply Gel Break Adhesive Remover full strength to the adhesive. Avoid over-application.
3. Agitate Gel Break Adhesive Remover into area with any hand held implements like GUM-GETTER or bone scraper. Poke into the contaminant surface to allow the Gel Break to penetrate.
4. Allow to dwell for 3-5 minutes.
5. Blot or scrape up excess Gel Break Adhesive Remover along with any adhesive that has been loosened. Repeat steps 2-5 if necessary.
6. Blot and rinse the area thoroughly, using extraction equipment and clean water.
7. Mist Spot Stop on treated areas. Brush Spot Stop to both align the fibers and evenly distribute the product.
