INSTRUCTIONS

Test for colorfastness. Always apply enough to assure direct contact with odor source. In some cases this means saturation. Virtually no dwell time needed. Add 4 to 8 ounces per gallon of water depending on the severity of the odor to spray on carpet, upholstery or hard surfaces.

Water Claw Usage: Saturate the area with diluted Hydrocide™ and flush area using the Water Claw and adding more water in the process. Follow up with a misting of the area with Hydrocide™ and/or Bridgepoint Bio-Modifier Xtreme. One additional benefit is that Hydrocide™ has a polymer in the formulation which retards resoiling. Prespray Additive: Add up to eight ounces per gallon of ready to use prespray to deal with odors prior to cleaning. Be aware that the addition of Hydrocide™ may neutralize some fragrances.

INSTRUCCIONES

Haga una prueba en un área poco visible para asegurarse de que el material no se destiñe. Aplique una cantidad suficiente del producto para que llegue a la fuente del olor. En algunos casos será necesario cubrir completamente el material. No se requiere casi nada de tiempo de reposo. Agregue de 4 a 8 onzas por galón de agua, dependiendo de la severidad del olor, luego rocíelo en la alfombra, tapicería o superficie dura.

Uso del "Water Claw": Cubra completamente el área con diluido Hydrocide™ y luego enjuague completamente uso el Water Claw, agregando más agua en el proceso para eliminar la fuente del olor.
